Community and Behavioral Health Services - No cost intervention and referrals for youth and their families in crisis situations including immediate crisis stabilization, 23 hour timeout services, anger management and substance abuse education. Provide behavioral health services to low income children and their families enrolled in the Magellan of Arizona system. These services include counseling and psychiatric services, in-home family support, after school and respite programs, and crisis counseling.

4b (Code:) (Expenses \$ 6,893,845. including grants of \$ 0.) (Revenue \$ 8,208,259.)

Youth Services - Residential Treatment Centers - Three 24 hour, licensed, thereapeutic homes for boys ages 12 to 17 experiencing emotional handicaps and behavioral challenges. Services include individual, family and group therapy, referrals are made by the court and correction system, welfare services, behavioral health systems and other stakeholders. Also includes accredited specialized education to boys and includes individual education plans for students with learning disabilities, cultural diversity classes, low student to teach ratio, subject focused block system. The Detention Alternative Program is a 30 day residential program offering an alternative to juvenile detention for boys ages 12 to 17 who are referred by the court and corrections systems. Services include certified on-site education and individual, group and family counseling.

4c (Code:) (Expenses \$ 2,897,946. including grants of \$ 0.) (Revenue \$ 2,371,239.)

Emergency and Shelter Services Domestic Violence Centers including case management, advocacy, domestic violence, life skills, and parenting education. Services for children and basic needs such as food and hygiene products. Homeless Shelters - La Mesita homeless shelter provides 30 homeless families with child support to self reliant. Services include accredited childcare and youth services, provision of basic living needs, case management and employment resources. The East Valley Mens Shelter provides services for 84 homeless men who are committed to gaining employment and becoming self sufficient. Services include case management, food and basic needs, and work assistance. Emergency Serivces include financial and case management services to individuals and families facing emergency situations impacting their housing, utilities and safety.
