# Parents and Children Teaming Together

## compassionate services

**Parents and Children Teaming Together (PACTT) is an in-home and community-based support and rehabilitative health service for children and their families with challenging needs.** The PACTT program will help your family achieve healthy relationship dynamics, household peace, and overall stability in the household.

PACTT consists of a diverse team of behavior coaches providing individualized services to accomplish goals set by each Child and Family Team fitting the family's culture, needs, and schedules. PACTT serves over 100 children and families each year, working to encourage positive behavior and family dynamics. Children receiving services through PACTT are eligible until they age out of the system.

Programming centers on encouraging positive relationships between children and families, focusing on positive opportunities, choices, and developing a respected role in the community. Behavior Coaches also provide support for children in achieving success in school academically, socially, and behaviorally. This will reduce frequency of emotional/behavioral episodes, while improving stability and emotional health.

## eligibility & enrollment

This program is a Title XIX funded service offered to children and teens aged 0-17 who qualify. To qualify, the child must be AHCCCS eligible and referred through their Child and Family Team (CFT). Children receiving services are eligible until they turn 18. Youth are able to return to services in this program as needed.

# healing help for your family

PACTT uses Positive Behavioral Support practices, in accordance with the State of Arizona Meet Me Where I Am Campaign. The primary focus and goal of MMWIA is to help children and their families live successfully in their own communities.

A common cycle of services is as follows:



- Emotional management training
- Positive behavior modeling and training
- Family support and parent coaching
- Community integration practices
- Medication education
- Self-expression skills
- Social, living, and communication skills
- Self-regulation and decision skills
- Self-sufficiency skills
- Conflict resolution skills
- Health promotion and education
- Ongoing assistance to attain and enhance natural supports



## location

PACTT services are tailored to the child and family in the most appropriate of settings. Support services are provided across Maricopa County, in the community, schools, and homes.
