The outpatient clinic is able to provide services to enrolled patients from birth through 64 years of age. Presenting behavioral health issues addressed may include: attention deficit hyperactivity disorder, depression, anxiety disorders, adjustment disorders, relationship issues, and substance use. The clinic also offers support tailored to trauma-related challenges, such as abuse, neglect, and domestic violence.
