A New Leaf's Sexual and Domestic Violence Services provide essential, trauma-informed support for those who have experienced past and/or present sexual violence or domestic violence in Maricopa and Pinal Counties. Help is only a call away.

Sexual Violence Services

A New Leaf's Sexual Violence Services address the unique short- and long-term emotional safety and healing needs of those who have experienced sexual violence in the past and/or present. Survivor-driven, healing-centered services are offered at the REACH Center, located in Mesa, or can be offered through mobile, remote, or virtual options. Support is offered to survivors of all gender identities, gender expressions and sexual orientation.

Domestic Violence Services

A New Leaf's Domestic Violence Services provide for the immediate physical and emotional safety needs of those experiencing abuse in their home or familial relationships. Services provide a trauma informed approach to safety planning, supporting survivors with a variety of needs, and assisting them to safely move forward with their lives. Areas of service include:

- **Shelter and Housing:** A New Leaf's Domestic Violence shelters are dedicated to helping survivors find safety, stability, and independence after leaving an abusive partner.
- **Community Based Services:** A New Leaf offers a variety of services within the community including civil court and lay legal advocacy, personal advocacy and case management, parenting and art-based workshops for families, and educational/awareness/training presentations.
